Greater Wellington is now at the stage of Hearings where submitters have the opportunity to speak to the panels about their submission. We have two hearing panels appointed for this Hearing:

- The Part 1, Schedule 1 (P1S1) Hearings Panel, appointed by the Council, who will hear and make recommendations on submissions in relation to the Part 1, Schedule 1 provisions of RPS (Regional Policy Statement) Change 1
- The Freshwater Hearings Panel (FHP), appointed by the Chief Freshwater Commissioner, will hear submissions on the Freshwater Planning Instrument component of RPS Change 1.

The Hearings will be split up into 7 streams, each covering a specific topic. This notice relates only to Hearing Stream Seven Small Topics, Wrap Up and Variation 1.

Hearing Stream Seven (HS7) will commence on Monday 15th April 2024 at 9:25am (time to be confirmed) and will cover the topics of Consequential Amendments, Definitions - Regionally Significant Infrastructure National Grid and Strategic Transport Network, Natural Character, Omitted Submission Points and Variation 1. Five days have been set aside for this final Hearing Stream.

You are eligible to appear at Hearing Stream Seven if you or your organisation provided one or more Submissions or Further Submissions on the provisions within the topics of Variation 1, Consequential Amendments, Natural Character, Regionally Significant Infrastructure and Omitted Submissions. Presenting to Submissions

The Hearing Panels will have read all submissions, evidence, and pre-circulated documents prior to the Hearing. Your presentation should focus on the key points of your submission.

The Hearings Panels have advised that submitter presentations should be approximately 10 minutes. Please note that this time **does not** include questioning time from the Hearings Panels, question time will be added to your allocated speaking time.

If you think that 10 minutes is not sufficient time for your presentation, we encourage you to request a time extension at this stage. When the Hearings are in session it impacts other Submitters and the timetable if your presentation takes longer than the time you have been allotted.

If you require longer than 10 minutes for your presentation time, you need to request this by completing the Confirmation of Speaking Form (below) by 5pm, Monday 25th April 2024. This request must include a justification as to why extra time is required, and an indication of how much extra time you may require.

If your time requirement changes after the Report Author Rebuttal Evidence have been posted (before the start of the Hearing), and you require more time for your presentation, please contact the Hearings Advisor **ASAP** via email regionalplan@gw.govt.nz
