This function has a dual purpose: recognising outstanding staff achievements and contributions, and celebrating the end of the year. Greater Wellington does not contribute any funding for other end of year celebrations.

This does not apply to a number of employees who work in our parks, Contact Centre, the Harbours team and anyone who is rostered on one of our response rosters.

 - 119 people leaders are taking leave additional to the mandatory three days as outlined in the above section.
