## Request for information 2025-036

I refer to your request for information dated 19 February 2025, which was received by Greater Wellington Regional Council (Greater Wellington) on 19 February 2025. You have requested the following:

"This is a request for official information concerning Metlink's spending on consultancy services, external advice.

We request the following information:

Consultancy Services and External Advice:


- The total amount spent by Metlink on consultancy services and external advice from January 2020 to the present exceeding \$10,000.
- A detailed breakdown of consultancy services by project, including:
  - The name of the consultancy firm.
  - The scope of work for each project including dates.
  - The total cost associated with each project.
- Copies of any assessments or reviews conducted on the value and effectiveness of these consultancy services."

## **Greater Wellington's response follows:**

The total amount spent by Metlink on consultancy services and external advice from January 2020 to the 19 February 2025, on projects exceeding \$10,000 was \$5,128,543.32. Please note

that the bulk of this amount dates to the period 2020-2021 for projects relating to the Covid-19 response and for the implementation of Snapper on rail.

Please refer to the graph below for the expenditure on consultancy services and external advice on projects exceeding \$10,000 on an annual basis.



Regarding your request for a detailed breakdown of consultancy services by project, our decision on the request is that we will be releasing a breakdown of the consultancy services by project dating back to 1 January 2020 as a pair of excel spreadsheets. We intend to provide you with these documents by the close of business on Friday 28 March.

Please note that some information from these documents will be withheld under section 7(2)(a) of the Local Government Official Information and Meetings Act 1987 (the Act) to protect the privacy of persons mentioned. Where information will be withheld under this section, this will be clearly noted.

Additionally, please note that prior to the 2021-2022 Financial Year, Greater Wellington used a different financial system. Therefore, information prior to this date will be formatted differently and the information that was captured and recorded under this prior system will differ from later records.

## Copies of any assessment or review on the value and effectiveness of these consultancy services

In investigating this part of your request, we have not been able to locate any assessment or review undertaken on the value or effectiveness of these services.

Therefore, we have refused this part of your request under section 17(e) on the basis that that the document alleged to contain the information requested does not exist or, despite reasonable efforts to locate it, cannot be found.

In refusing this part of your request under this section we have considered if consulting with you would allow you to make your request for this information in a manner that would remove the reasons for the refusal. It is our consideration that this request couldn't be reworded in a form that would allow us to locate this information for you.
