Request for information 2025-206

I refer to your request for information dated 02 July 2025, which was received by Greater Wellington Regional Council (Greater Wellington) on 02 July 2025. You have requested the following:

"In the slides for the Bus Priority Lanes on the Harbour Quays GWRC stated that by 2034 without the Harbour Quays Bus Lanes the number of peak hour buses per hour on the Golden Mile would increase from 103 to 135 buses per hour.

Could you please provide the evidence for this 30% increase in peak hour bus numbers in the next 9 years."

Greater Wellington's response follows:

The numbers were calculated by applying unconstrained growth forecast to the expected peak number of buses using the Golden Mile in 2025.

Below are the forecast numbers, please note that the planned closure of Brandon Street means that these buses are added to the totals for the relevant directions.
