At its meeting on 22 May 2025 the Council appointed three delegates for the LGNZ Annual General Meeting, namely Councillor Adrienne Staples, Councillor Quentin Duthie, and Nigel Corry, Chief Executive. There was no remit to use ratepayer money to fight against rates capping. The meeting did agree to continue to investigate the effects of any legislation the Government may propose and that any decision about a way forward would be made at a LGNZ Special General Meeting to be held after the 2025 triennial local elections.

Councillor Adrienne Staples, who was Greater Wellingtons presiding delegate at the LGNZ AGM, voted in favour of the approach outlined above on behalf of Greater Wellington.
