The Council Chair accorded priority to agenda item 9 Living Wage Accreditation: Approval for Application and Milestone Plan – Report 25.382 and agenda item 10 Council's response to Porirua Citizens Assembly recommendations – Report 25.395, in accordance with Standing Order 3.5.2.

6 Living Wage Accreditation: Approval for Application and Milestone Plan – Report 25.382

Kareena Harris, Senior Procurement Advisor – Living Wage/Social Procurement, and Hemi Kanji, Manager Procurement, spoke to the report.

Moved: Cr Saw / Cr Ponter

That Council:

- 1 Notes the investigations detailed in the previous report (Living Wage Accreditation Update – Report 24.348) determined that suppliers, other than in public transport, engaged by Greater Wellington on contracts for services and falling within accreditation requirements are already paying Living Wage and as a consequence, Greater Wellington will not incur

additional cost to initially ‘uplift’ payments to accommodate for payment of the Living Wage.

- 2 Notes that Living Wage payments associated with rail operator sub-contracts will not be factored into the rail operator contracts until 2031 and, therefore, the financial impact will be from 2031 onwards and will be higher due to the increase in Living Wage over time.
- 3 Notes the milestone plan aligns with contract retendering dates to enable the costs to be accommodated in the 2027/28 Long Term Plan funding requests and proposes that Greater Wellington will be paying Living Wage in all contracts by 2031.
- 4 Agrees to apply for accreditation with Living Wage Aotearoa to become an accredited Living Wage Employer.
- 5 Notes that should Greater Wellington not meet its agreed milestones and continue to pay the Living Wage, it will lose accreditation status resulting in reputational impact.
- 6 Agrees to consider in the 2026/27 Annual Plan process, in the context of other funding priorities in a constrained fiscal environment, funding an uplift for contractor and subcontractor employees not already receiving the living wage.

7 Council’s response to Porirua Citizens Assembly recommendations – Report 25.395

- 1 Acknowledges its support of the six recommendations of the Porirua Citizens Assembly on Climate.
- 2 Notes the activities Greater Wellington is already undertaking which align to the assembly recommendations (Attachment 1).
- 3 Recommends that the key opportunities/programmes identified in paragraph 26 of this report should be considered by the incoming Council in the process of preparing the 2027-37 Long Term Plan.
- 4 Agrees that a letter is prepared which provides a formal response from the Chair and Chief Executive, on behalf of Greater Wellington, to Helmut Modlik, on behalf of the Porirua Citizens Assembly, reflecting the decisions Council agrees to based on this report.

8 Local Water Done Well – Approval of the Water Services Delivery Plan – Report 25.372

Julie Knauf, Group Manager Corporate Services, and Amanda Cox, Programme Director Local Water Done Well, spoke to the report.

That Council:

- 1 Notes that the joint Water Services Delivery Plan (WSDP) for the Wellington metropolitan area, as attached as Attachments 1 and 2 to this report:
 - a is based on the Department of Internal Affairs (DIA) template and guidance including for financial modelling;
 - b has had input and development from a range of technical experts;
 - c has been the subject of robust legal and technical reviews;
 - d has been subject to independent financial and delivery model peer review;
 - e has used the best available information and includes detailed risk analysis;
 - f has been certified by the Chief Executive that it complies with the Local Government (Water Services Preliminary Arrangements) Act 2024 (the Act) and that the information contained in the WSDP provided by Greater Wellington is true and accurate.
- 2 Adopts the joint Water Services Delivery Plan (WSDP) for the Wellington metropolitan area.
- 3 Notes that, following adoption by all five councils, the joint Water Service Delivery Plan will be submitted to the Secretary for Local Government (via the Department for Internal Affairs) on behalf of all five councils by the legislated deadline of 3 September 2025.
- 4 Notes the draft foundation documents presented with this report (Attachments 3 to 6) represent the collective direction to date and will continue to be developed further.
- 5 Endorses the draft Constitution (Attachment 3) noting that the draft Constitution will be approved by the Advisory Oversight Group (AOG) and then finalised for ratification by Council and partner organisations following the 2025 triennial local elections.
- 6 Endorses the draft terms for the Partners Agreement (Attachment 4) noting that the draft Agreement will be approved by the AOG and then finalised for ratification by Council and partner organisations following the 2025 triennial local elections.
- 7 Endorses the draft principles for the development of the Statement of Expectations (SOE) (Attachment 5) noting that the principles for the SOE will be finalised for ratification by Council and partner organisations

following the 2025 triennial local elections, with the SOE to then be finalised and approved by the Partners' Committee.

- 8 Endorses the draft principles for assisting the Water Services Council Controlled Organisation (working name Metro Water) to develop a Customer Charter, (Attachment 6) noting that these principles will be finalised for ratification by Council and partner organisations following the 2025 triennial local elections, and will be incorporated into the final SOE to be implemented by Metro Water.
- 9 Notes that a number of matters of importance to Greater Wellington require further work and will continue to be advanced by Greater Wellington through the AOG and the process ahead.
- 10 Notes the 1 July 2025 version of the Memorandum of Intent (Attachment 7), which includes the updated Terms of Reference for the AOG, as approved by Council at the 26 June 2025 meeting.

9 Waterloo Transit Oriented Development: Reference Design options analysis – Report 25.323

Emmet McElhatton, Manager Policy, Nathan Briggs, Manager Rail Assets, and Campbell Jensen, RCP Ltd, spoke to the report.

That Council:

- 1 Notes that as part of the Waterloo Transit Oriented Development project decision-making process, Council is being asked to determine the Reference Design option for the Waterloo Transit Oriented Development project.
- 2 Notes that five Reference Design options have been shortlisted for Council consideration:
 - a Option 1: 'Do nothing'
 - b Option 2: Upgraded underpass
 - c Option 3: Shortened underpass with pedestrian crossing
 - d Option 4: Long overpass
 - e Option 5: Short overpass (preferred option).
- 3 Notes that Option 5 is considered the best and most cost-effective option to deliver Council's agreed objectives (refer to Initiating Transit Oriented Development in the Wellington Region – Report 21.501 and Waterloo Priority Development Area – Report 24.131) for the transit-oriented development programme and thus take forward to business case and Go-to-Market phase.

- 4 Agrees to take Option 5 forward to full Reference Design and business casing.
- 5 Notes that Option 5 includes - aligned and upgraded platforms, underpass removed, new overpass providing access from Oxford Terrace to Cambridge Terrace, at-grade pedestrian crossing from Cambridge Terrace to Trafalgar Square, and two sets of new enclosed sheltered entries with compliant stairs and lifts for accessibility.
- 6 Notes that the Phase III project work has raised concerns about the long-term feasibility of retaining an underpass at Waterloo Station due to questions of integrity of the current infrastructure and likely environmental and regulatory compliance challenges associated with renewing or replacing the current underpass.
