

Reference guide to CMT applicants in your area (as updated by GWRC on 05 February 2018)

If you are applying for resource consent in the common marine and coastal area **you need to notify and seek the views of any group that has applied for recognition of customary marine title in the area**, as per section 62 of the Marine and Coastal Area Act. This must take place prior to submitting your resource consent application.

GWRC have compiled a list of customary marine title applicants in their jurisdiction based on the information currently made available. This has been recorded per area as follows:
